



INTERNATIONAL APPLICANTS



EVALUATION ELEMENTS

- Mandatory Test: GMAT, GRE (verbal and quantitative sections only) or online Bocconi test
- **GPA** of exams or courses passed during the undergraduate program by the time you apply
- Curriculum Vitae/Resume
- Personal Statement
- Video Presentation not mandatory



5 selection rounds are available throughout the year:

Up to 5 programs can be selected in the same application.

EXCHANGE STUDENTS

Past and current incoming exchange students can apply at the same time as other international applicants. Dedicated entry conditions are applicable.

SPECIAL PROGRAMS AND DOUBLE DEGREES

IM CEMS MIM, IM Asia - China MIM and IM Asia -DD Bocconi-ESSEC

Application to these programs takes place at the same time as admission to the regular MSc programs. These programs must be chosen independently from other MSc programs.

LSE-Bocconi, Sciences Po-Bocconi Double Degrees Applications to these Double Degree programs are independent and not included in the 5 choices mentioned above. Check online for more information on the dedicated selection rounds and specific requirements for these Double Degree programs.

Fees and Funding

Bocconi tuition and fees will be € 18,000 per year in the 2024-2025 academic year.

The tuition is divided into different installments that students pay throughout the year. **Bocconi is committed to supporting deserving students** through our financial aid system based on both merit and need. Financial aid opportunities include the following:

- When evaluating students for admission, top candidates may be assigned a Merit Award covering 100% of yearly tuition and fees. There is no need to apply for these merit scholarships as the Scholarship Committee assigns them independently.
- European students and students with a permanent address in Italy may apply for low interest loans thanks to agreements between Bocconi and major European banks.
- US citizens can apply for a federal loan (FAFSA).
- Enrolled students may also apply for an ISU Bocconi Scholarship or for contributions for participation in international mobility and internship programs.


